

## **Rules and Regulations The Art Of Freedom Competition**

### **Article 1**

The aim of the competition The Art Of Freedom is to stimulate awareness about the theme Freedom by using creative ways of self expression.

### **Article 2**

The canvas that you create is your own work. You shall indemnify the Lava Legato Foundation and hold the Lava Legato foundation harmless against any third-party claims arising from the work that you submit.

All resources are allowed to create your canvas, including your own pictures, provided and self chosen backgrounds and self written text.

### **Article 3**

The subscription will close on September 30, 2020 12:00 AM.

Everyone can participate.

You can send as many applications as you want.

A canvas that is considered unethical or disrespectful is excluded.

You can only apply when you register on the Royal Playground website. To do this you need to submit your official name and date of birth.

### **Article 4**

There are two categories of prizes:

Under 18:

An art tool set containing art supplies worth € 150,00.

Over 18:

A weekend trip to Rotterdam for two people, including, a travel budget for € 150,00 per person, a double room for two people in Stay Okay in Rotterdam, a city tour centred around the theme Freedom and two free tickets to the exhibition Art Can Be Anything in the Chabot Museum. In case you cannot come to Rotterdam, there is also an option to choose for the art tool set that also can be sent abroad.

### **Article 5**

#### **Selection**

A first selection will be done by a team of the Lava Legato foundation representatives. Ten pieces will be selected for both categories.

A jury will select the price winners for both categories.

The Lava Legato Foundation has the right to exclude an entry before, during or after judging.

### **Article 6**

#### **Intellectual property**

You guarantee that the canvas you created is your work and/or that you only make use of work of others that does not contain copyright.

By submitting your canvas, you allow the Lava Legato Foundation to use your work for publication and promotion purposes, for instance on social media.

The Lava Legato foundation shall not be entitled to any reimbursement in respect of the use of your canvas.

#### **Article 7**

##### **Result Binding**

The final decision of the jury is binding and no correspondence will be entered into on this decision.

#### **Article 8**

##### **Other**

Lava Legato Board members, volunteers, suppliers, freelancers and their family are excluded from participation.

In case you are a nominee or winner, your real name will be published.

In line with privacy regulations, no information is shared with third parties.

In line with privacy regulations, you are able to withdraw from the competition, two weeks prior to the jury announcement.

The Lava Legato foundation may on its own initiative, without warning or notice, change these conditions during the application period.

By accepting these conditions during the application period, you allow the Lava Legato foundation to get in touch with you in case further information is needed.

By accepting these conditions, you confirm that the personal details (name and date of birth) that you submit are correct.

The Dutch Law is applicable to these conditions.
